



**Village of Wagon Mound
Ordinance No. 605-J-13
Water Rates, Rules and Regulations
Amendment 2017-02**

Section 9: Disconnection and Restoring of Service

AN ORDINANCE ENACTING, AMENDING, AND REPEALING THE FEE FOR RESTORING SERVICE AS STATED IN SECTION 9 OF THE CODE OF THE VILLAGE OF WAGON MOUND OF ORDINANCE NO. 605-J-13: WATER RATES, RULES AND REGULATIONS DATED JANUARY 13, 2014.

BE IT ORDAINED by the Governing Body of the Village of Wagon Mound

SECTION 3: RATES

The residential rates and commercial rates shall be effective on the next billing period, after this ordinance is PASSED. Housing Authority rates have changed. Rates shall be effective January 13, 2014. They shall be as follows:

CONSTRUCTION RATES: NEGOTIABLE AT THE TIME OF CONTRACT

RESIDENTAL RATES: MINIMUM CHARGE \$15.25 FOR THE FIRST 10,000 GALLONS

Next 5,000 gallons at \$2.25 per 1000 gallons
Next 5,000 gallons at \$2.75 per 1000 gallons
Next 5,000 gallons at \$3.25 per 1000 gallons
Next 5,000 gallons at \$3.75 per 1000 gallons
Anything over 28,000 is \$4.25 per 1000 gallons

1. **COMMERICAL RATES:** The charge will be assessed to every person, firm association or corporation receiving any other services such natural gas, water and sewer that are providing to the public.
 - a. Grocery Stores
 - b. Convenience stores
 - c. Cafes and restaurants
 - d. Office, including real estate, medical and other professional office
 - e. Motels
 - f. Drug stores
 - g. Services stations, automobile sales and services, garages, body shops
 - h. Dry goods stores, variety stores, appliance and/or tire stores automotive parts, department stores
 - i. Banks
 - j. Barber shops and beauty parlors
 - k. Florist shops, wholesale or retail
 - l. Trailer parks
 - m. Apartment and multiple family dwelling

ALL OTHER COMMERCIAL BUSINESS ESTABLISHMENT NOT OTHERWISE SPECIFIED FEES WILL BE NEGOTIATED WITH THE VILLAGE COUNCIL.

COMMERCIAL RATES: MIN. CHARGE \$ 18.90 FOR THE FIRST 10,000 GALLONS

Next 5,000 gallons at \$3.15 per 1000 gallons

Next 5,000 gallons at \$3.68 per 1000 gallons

Next 5,000 gallons at \$4.73 per 1000 gallons

Next 5,000 gallons at \$5.25 per 1000 gallons

Anything over 28,000 gallons \$5.76 per 1000 gallons

School Rates: \$1016.40 Flat Monthly Rate

Wagon Mound Housing Authority Rates: \$900.90 Flat Monthly Rate

Water Haulers Rates: \$26.25 per thousand gallons

The Village reserves the right to base the minimum charge on either the meter hydrant or commercial or residential service lines.

HOOK UP FEE: Hook up fee is SIX HUNDRED DOLLARS (\$600.00)- starting at the center of the nearest Village water main (the first 20 ft.) of new service to include (if needed) asphalt and or concrete cutting, trenching, service install, water tap, pipe, fittings (meter loop, can and meter), trench filling, compaction, asphalt and or concrete replacement. NOTE: As may be required, the Customer will pay an additional \$20.00 per ft. after the first 20 ft. in order to complete new water service install to the Customers property line / proposed private water line connection point. If the Customer chooses to hire a qualified plumber the connection fees still apply. Commercial hook up rates will be adjusted to meet increased water line and or meter size as required.

SECTION 9: DISCONNECTION AND RESTORING OF SERVICE

The Village of Wagon Mound reserves the right at any time to DISCONTINUE OR DISCONNECT the water service of any customer for non-payment of bills, to prevent fraud or for any other sufficient reason. Payment is due the 15th of each month.

Consumers having unpaid Utility Accounts delinquent of two months, the past due balance must be paid in full or the consumers will be subject to termination. A notice of Intent to Discontinue Service will be posted to consumers' door and sent in the mail three days prior to shut-off. The consumer must pay his or her past due amount of utility bill or services will automatically be shut off. Consumer may only post-date a check up to three days.

NSF checks, a \$25.00 charge will be imposed by the Village of Wagon Mound on any returned check, plus any charge imposed by the bank. After the first check returned to us we will no longer accept your check due to the paper work involved.

DISCONNECTION OR DISCONTINUANCE of service as provided herein shall involve extra expense to the Village; *if service is shut down for non-payment there will be a \$50.00 fee to restore service and the bill must be paid in full before service will be restored.*


\$25.00 flat annual fee will be charged to restore water service. This flat annual fee of \$25.00 will be charged regardless of the number of shut-off and restoring of service requests made at a service location in a single calendar year. Any customer account having paid multiple reconnect fees during the calendar year of 2017 shall be credited for the additional payments to properly reflect this amendment. If a customer owes the Village for the past water service and desires to re-apply for such service, it will be necessary for the customer to pay all unpaid balances before service will be restored.

Charges for shutting off service or restoring service after normal business hours will be \$35.00.

The Village of Wagon Mound will not sell water to any company involved in the practice for fracking.




