The purpose of this public hearing will be to report on past CDBG program activities and to receive public input on community development needs and suggestions for future CDBG projects.

The Community Development Block Grant (CDBG) Program was established under Title I of the Housing and Community Development Act of 1974, as amended, in order to assist communities in providing essential community facilities, providing decent housing for residents, promoting economic development and maintaining a suitable living environment. The State of New Mexico estimates the 2017 appropriation of \$9,000,000 to be distributed statewide on a competitive basis.

State and national objectives of the 2017 CDBG Program require that assistance be made available for activities that principally benefits person of low and moderate income.

Applications are limited to a maximum of \$500,000 (\$750,000 for applications accompanied by a certified cost estimate from an engineer, architect, or landscape article, licensed to do business in the State of New Mexico), except for planning applications which have a limit of \$50,000.

Eligible activities and categories will be described. All interested parties are invited to attend, to submit project ideas, to provide supporting data and testimony, and other pertinent information.

With sufficient notice, a translator will be provided for non-English speaking residents.

- Roll Call was made by Municipal Clerk – Mayor Quintana, Councilor Miera, Mayor Pro- Tem Martinez, and Clouthier were present. Councilor Cruz was absent.

III. Business Matters:


1. *Discussion/Approval/Disapproval: To Close Out CDBG Water Project.

Mayor Quintana read the CDBG Public Meeting Agenda with emphasis on gathering information or ideas on past and future CDBG projects, also to inform our community members about the completed project, the total amount of the CDBG funding, the issues we've had during this project, and lastly if we wanted to go after more CDBG funding. Mayor Quintana asked if anyone had questions about the CDBG funding and Water project that was just completed. Councilor Miera asked about everything involved with the water project and Mayor Quintana informed him that we had one last thing to do, have the contractor grind down the asphalt and then he addressed the questions to the Municipal Clerk about when the contractor was coming back to do that. She informed them that they had until tomorrow and that she will call for an update on fixing the asphalt. Community member Mrs. Rosa wanted clarity on the CDBG funding for 2019, if this project was complete and she also inquired on other projects for the Village. Municipal Clerk informed all who attended that the contractor had 15 days to address any issues and that they should be here tomorrow. Mayor Quintana asked if anyone wanted to request new funding for CDBG and that the funding for it is \$500,000.00. Community member Mrs. Rosa stated we would have to come up with a large project for that kind of monies. Mayor Quintana stated even though this meeting closes the project we still need M & S Construction to come and finish the patch work, and that the price we paid the engineer was somewhere around \$365,000.00.

- Motion to Adjourn was made by Mayor Pro Tem Martinez, seconded by Councilor Miera. (Vote 3-0) Motion carried and all in favor. Meeting adjourned at 5:18 PM.
