• Community member Irene Rosa spoke about her concerns of the water in the Wagon Mound Village. She brought in a plastic bag full of plastic water bottles, she states she has been drinking bottled water because the water in Wagon Mound doesn't taste good anymore. She then went on to state that there is nothing for our kids to do here in Wagon Mound and if we can look into something for them.

• Community Member Norma Jean Vasquez had concerns about puppies and cats running around the Village and also stated that the owners of these animals need to get them all spayed or neutered. She is very concerned because these animals keep producing and it ends up with the Village full of unwanted animals that either get shot, ran over, or eaten by another animal. That is cruelty to animals. She also brought in a statistic flyer on animals pertaining to them not being spayed or neutered to show everyone.

VIII. Monthly Reports

- A. Utilities Delinquent List Utility Clerk Engelhardt
 - Delinquent active account-23, total \$1,996.44

- M & S Construction had a delinquent account and Municipal Clerk emailed their secretary explaining that they still owed for usage of the water meter and water for the construction of the water improvement project.
- Account #:115000 possible shut off. Community member staying in the house needs to come in by Friday to resolve delinquency, application complete, and deposit made.
- Account #:223500 water hauler/candidate for a lien. Discussed with attorney, he mentioned
 to call the Las Vegas office and get a sample letter of liens from them. Mayor Pro Tem
 requested to meet with the attorney here in Wagon Mound so he can meet the other clerks.
- Trash Cans are needed, the council members were addressed by Utility Clerk whether to purchase them or not. Mayor Pro Tem suggested we put this on the next council meeting as an item to approve to purchase trash cans.

B. Utilities Report - Utility Superintendent Sanchez

- A month ago GPM was down and reports of 25 gallons/minute. Gasket at the Daniels was bad, used 70 to 80 gal/minute, it is now fixed.
- 540 length in water line for the Rodeo Grounds and I will start in a couple of weeks. Mayor Pro Tem stated he would call Danny Gray with La Jicarita to see if we can use their Trencher and he stated it might be easier to do it with a trencher.
- The electrical line at the Rodeo, we need to know where it goes, Mayor Pro Tem Martinez stated that Community Member LeDoux is the one who put it up, and Councilor Clouthier stated he will ask him about the line.
- Waste Water, needing to discharge pumps 2 and 3 because they are high.
- Natural Gas working on 176 waiting on information from Colleen.
- Service to Tim Martinez set up next month and it won't take too long.
- DIMP is required by the PRC for the Village of Wagon Mound and that he is calling someone to help set this up and he also phoned Kenny Lucero and he informed us of who he went with to do the DIMP and stated they paid like \$8,000.00. Second week of June or the fourth week of June we are having Kevin Duke integrity management inspection, also gas inspection the same week and that will take 3 to 4 days to go over the whole system which consists of a 27 page inspection.
- Will keep us updated with John Jones on the DIMP set up.
- CDL past with 90% on the driving test.
- Trash Truck is not running, there is something wrong with the fuel.

C. MVD Reports – MVD Manager Romero was absent

- D. *Approval of Vouchers (payment to vendors) Finance Clerk Martinez was **absent** Municipal Clerk Eggert addressed the council members on the Vouchers and if anyone had any questions. No questions were presented.
- Motion to approve Vouchers was made by Mayor Pro Tem Martinez, seconded by Councilor Miera. (Vote 3-0) Motion carried and all in favor.

E. Mora County Sheriff's Office Report -

• Sheriff Espinoza introduced a new hire Dusty McDaniel, and he also introduced County Manager Joy Ansley and she will be speaking to the council about emergency ems needed here in Wagon Mound. He reported that Dusty had military background and wanting to waive the academy for him and that he lives in Cimarron. He also reported they just bought two new Chevrolet trucks and with the purchase of the new radio and programming they will be ready. They are filing a law suit through the Sheriff's Association too many

- constitutional laws. Capital Outlay we applied for 88 thousand and we want to purchase two more trucks. We are fully staffed with 5 deputies and two sheriffs.
- Medical services and Wagon Mound is in need of services. County Manager Ansley talked about the emergency vehicles coming up this way and maybe sit down and go over call volume for this area. She also stated there is a disconnect between Superior and the northern area for emergency services.
- The best way to contact them for their service is to call 911 it'll go to Las Vegas and they will call the Mora Sheriffs if they are needed. Sherriff Espinoza gave his cell number if anyone was in need of his services, and Deputy McDaniel made sure the Wagon Mound office clerks had his number as well if needed.

- Update on the Colfax Senior Center operations, they are working on their budget and will let us know after.
- Letter from the attorney Brian Colon releasing and approving us to pay our auditor.
- Capital Outlay projects; received \$128,000.00. Mayor Pro Tem Martinez reminded everyone at last meeting what the contractor and architect said about the amount it'll take to complete all new kitchen equipment they stated \$120,000.00. We will hold them to that amount and the Mayor is the one who mentioned that all the equipment that is in the old Senior Center stays in the old Senior Center so we can rent it out, all said it was a good idea.
- Finance Clerk attended a workshop to get her certification for a Chief Procurement Officer.
- DOT came out with two proposals: Hardship and Annual Public Entity Sale. Mayor Pro Tem Martinez asked for a list of what will be available, at last month's council meeting and no list was available as of yet stated Municipal Clerk. He then asked what is it that we need for the Village and Utility Superintendent Sanchez stated a Sweeper.
