Community Development Block Grant Program Village of Wagon Mound

A RESOLUTION OF THE (Village Council) OF (Village of Wagon Mound), NEW MEXICO, AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE (Mayor Laudente T. Quintana, Jr.) TO ACT AS THE (Village of Wagon Mound) CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE (Village of Wagon Mound) PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the need exists within (The Village of Wagon Mound) for neighborhood improvement projects in several low and moderate income neighborhoods, and the (Village of Wagon Mound) desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for the Final Phase of the New Senior Citizen Center.

WHEREAS, the (Village Council) has held (two) public hearings for public input and comment during the 2016 application process; and

WHEREAS, the (Village Council) finds that there is a significant need to complete the Final Phase of the (New Senior Citizens Center) to provide adequate services to the community; and

WHEREAS, the (Village Council) determines that the Final Phase of the (New Senior Citizens Center) meets the requirements of the Community Development Block Grant Program.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE (Village of Wagon Mound), NEW MEXICO, that

1. The (Village of Wagon Mound) is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/Local Government Division for the Final Phase of the (New Senior Citizens Center Project);

2. That the (Village Council) directs and designates the (Mayor Laudente T. Quintana, Jr.) as the (Village of Wagon Mound) Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the (Village of Wagon Mound) participation in the New Mexico Community Development Block Grant Program.
3. The (Village of Wagon Mound) officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution.
4. The full application amount be for \$500,000.00 of grant funds and Phased be for \$475,000.00 for The Final Phase of the New Senior Citizen Center
5. That it further be stated that the (Village of Wagon Mound) is committing (\$25,000.00) as a cash contribution toward the (Plan, Design, and Construction) activities of the (Final Phase of the New Senior Citizen Center).

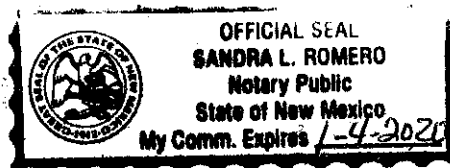

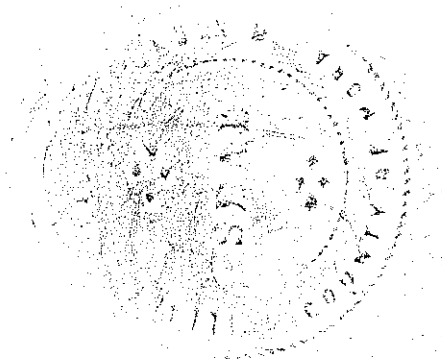

WHEREAS, Village of Wagon Mound acknowledges the importance of assuring fair and equal treatment to all citizens;


NOW, THEREFORE the Mayor and Council of the Village of Wagon Mound, Do hereby proclaim April 20th, 2016 as:






