

Village of Wagon Mound Resolution No. 2021-06

EQUEST FOR MATCH WAIVER FOR LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED. BY THE NEW MEXICO DEPARTMENT OF TRANSPORTATION

<u>WHEREAS</u>, the **Village of Wagon Mound** and the New Mexico Department of Transportation shall enter into a Cooperative Agreement;

WHEREAS, the total cost of the project will be \$40,000 to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or \$30,000
- a. The Village of Wagon Mound proportional matching share shall by 25% or \$10,000

TOTAL PROJECT COST IS \$40,000

The Village of Wagon Mound shall pay all costs, which exceed the total amount of \$40,000.

WHEREAS, the <u>Village of Wagon Mound</u> has a limited tax base, which limits the funding for meeting the proportional matching share; and, a fund exists in the NMDOT appropriation by the New Mexico State Legislature for Public Entities in need of "hardship" match money and <u>the Village of Wagon Mound</u> requests articipation in this Match Waiver Program in the amount of <u>\$10,000</u>.

Now therefore, be it resolved that, the **Village of Wagon Mound** determines, resolves, and orders as follows:

That the project for this Cooperative Agreement is adopted and has a priority standing.

The agreement terminates on **December 31, 2022** and the **Village of Wagon Mound** incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged in the written agreement.

NOW therefore, be it resolved by the **Village of Wagon Mound** to enter into Cooperative Agreement Vendor Number **46280**, Control Number **L400559** with the New Mexico Department of Transportation for LGRF Project Year **2021-2022** for the **plan**, **design**, **construction management**, **construction**, **reconstruction**, **pavement rehab**, **drainage improvements and miscellaneous construction to various Village streets** within the control of the **Village of Wagon Mound**, in Mora County, New Mexico.
